Turbine Jet Models	The pilot(s) plus anyone else in the vicinity	Fire extinguisher must be near the model when starting & moving through pits to flight line. The person with the fire extinguisher must be aware how, when & where to use it	None	Pilot of Jet powered aircraft	Immediate

Injury or Health Issues	Anybody	If any member has a medical condition that could be considered critical or life threatening if not dealt with immediately. They must let club members know & what to do This is in case we have to act for you regarding a health issue whilst at the field. It could be from anything that could be life threatening. Bungee System	Anybody	Making everyone aware it is in use. Ensuring members know where it is positioned. Being aware of the bungee when also taking off / landing	Reminding flyers when it is in use and when fixed into the ground.	Everyone	Immediate	
Wind Sock	Pilots / Models	To be in use whenever flying is taking place. This will help everyone, as the wind direction can change at times quickly	Wind sock to be put in place when flying and stored at the end of the day. Please store it safely & in its recommended place so to be available at the next flying session	Everyone	Immediate
